Construction of Tumaini Senior Secondary School in Makiyuni, Tanzania. Construction began in Jan 2015 and the school opened in January 18, 2016 with 45 Form I boarding students. Each year for the next three years, we will add another class, until, in 2019, the school will offer form I through form IV and serve approximately 240 students.
Construction continues throughout the year.

Construction of Tumaini Pre-primary school in Karatu, Tanzania. Construcion began in November, 2016 and the School was opened in March 2017. Construction continues while the school is in session. We will add a well and dining facility in 2017.
