**Grants to small wild cat conservation programs in cooperation with the Mohamed bin Zayed Species Conservation Fund (MbZSCF).**

James Sanderson is a member of the review board for MbZSCF that awards grants to species conservation projects globally.

James reviews all wild cat conservation proposals 3 times a year for MbZSCF. the small wild cat conservation project's budget is \$112,000 annually. To support all worthy camli wild cat projects the Small Wild Cat Conservation Foundation can make up any shortfalls in funding or fund more projects. Thus more small cat conservation projects can be started and also continued.

**Scottish Wildcat reintroduction project.** The Scottish wildcat project plans to breed in captivity and then release Scottish wildcats.

The issue is that feral domestic cats breed freely with Scottish wildcats, and as a result very few pure Scottish wildcats exist.

Feral domestic cat control is needed, as is cooperation from large estate holders.

**Sri Lanka fishing cat conservation project.** The fishing cat is an endangered species. Small Wild Cat Conservation Foundation created and supports several fishing cat conservation projects from Pakistan to Cambodia. Active threat reduction measures include working with communities, and the installation of traffic signs to reduce vehicle strikes.
