THE IHC IS A GLOBAL HUMANITARIAN HUB OF 65 NON-PROFIT AND INTERGOVERNMENTAL ORGANIZATIONS, UN AGENCIES, AND COMMERCIAL ENTITIES IN THE REGION, SUPPORTING DEVELOPMENT AND RELIEF EFFORTS IN THE MIDDLE EAST, ASIA, AMERICAS AND AFRICA. MEMBERSHIP TO THE IHC IS BY INVITATION ONLY, AND FIXED COSTS ARE HIGHLY SUBSIDIZED THROUGH THE UNITED ARAB EMIRATES. THIS PRESENCE WILL PRIMARILY LEVERAGE THE WATER PROJECT'S EXISTING RELATIONSHIPS TOWARDS WATER ACCESS PROGRAMS IN THE IMMEDIATE REGION, AND WILL ALSO PLACE THE WATER PROJECT CLOSER TO AFRICA PROGRAMS.
