For the year, our primary work consisted of individual artist fellowships, and piloting community based programming that engages communities on social impact. We also sponsored a limited number of Native arts and cultures related activities, and provided counsel to the field through a number of avenues.

Our advocacy efforts are informed by the lessons of our years of work towards communicating needs to the greater public. As catalysts for Native enrichment and cultural equity, we focus on publicizing the groundbreaking work of our fellows and projects, organizing issue-oriented conference presentations by our fellows and staff, and sponsoring efforts that further indigenous knowledge and the arts. We also publish opinion and research articles, for example in 2017 we will publish an evaluation of our first four community inspiration projects, and two years of fellowship applicant demographic data and analysis.

Facts And Circumstances Test

For 2016, our calculated public support ratio was 18%, consistent with prior years. Our unqualified support comes from four separate, long-established private foundations. For the calculation period, we received more than \$768,000 in qualified support from over 400 public sources that included government agencies, public foundations, private foundations, and individual donors, and which ranged from \$5 to \$100,000 in size. Approximately 80% of those individual donors had made repeat donations. Our bylaws require that our leadership be representative of our public stakeholders and mission. Our board must be composed of a majority of individuals of American Indian, Native Hawaiian or Alaska Native recognition, and our president/CEO must also be Native. At the end of 2016, our president/CEO was Native Hawaiian, and our 10-person board consisted of one Alaska Native, one Native Hawaiian and seven American Indians. Until his untimely death in 2016, Board member David Hatch was a member of the Siletz Tribal Council. Board member Cheryl Andrews-Maltas is the chairwoman of the Wampanoag Tribe. The other board members are representatives of the arts, culture, philanthropy, education and the community. Since our inception we have invested heavily in our mission and programs. As of the end of 2016, we had invested over \$7.6 million in 236 awards supporting 188 individuals and organizations in 30 states and DC. Over the calculation time period our programmatic expenses have ranged from 72 to 76% of total expenses. The majority of our direct awards are made through a publicized open application process judged by an impartial panel of peers. One purpose of our website and social media is to continually inform the public about the work of our fellows. During the course of 2016, our website was viewed more than 20,000 times by the public. We currently publish a bi-monthly email newsletter whose 2016 distribution reached 5,760 public subscribers. To further our interaction with the public, we strategically assessed our social media channels to leverage their potential for stakeholder engagement, program transparency, and public education regarding current events, news and opportunities around Native arts throughout the United States. Following this overhaul, by the end of 2016, our Facebook channel attracted 7,278 followers, our Twitter account had 1,420 followers, our LinkedIn account had 156 followers, and our Youtube channel was re-organized to better tell the stories of the artists and organizations we support. Our headquarters office is located on the ground floor of an historic building owned by a public non-profit with plenty of parking and is ADA compliant. We regularly field general telephone inquiries from the public on the subject of Native arts and cultures, and provide direction where possible.
