Farm Forward made a loan to Frank Reese. This loan was the first made under the "Pay it Forward" loan program, where Farm Forward assists farmers engaged in very high-welfare farming that has the potential to be a model for other farmers. Mr. Reese is the first and only beneficiary of this loan program so far. The loan terms were straightforward with a nominal interest rate of three percent per annum. The loan is being secured by Mr. Reese's farm. These terms are identical to those that would be extended to farmers not related to the organization. It is currently in default and negotiations will be pursued to arrive at a satisfactory settlement agreement.

The loan to Aaron Gross was part of the organization's Home Assistance Loan Program. The loan is now fully repaid.
