As of December 31, 2016 the total amount outstanding applicable to ROHVA was \$5,323. ROHVA leases office space in Irvine, California under a noncancelable operating lease agreement, which expires in August 2020 and requires minimum monthly payments of approximately \$24,000. ROHVA shares the office space and related expenses with MSF, SVIA and MIC. ROHVA's pro rata share of the monthly lease payments is approximately \$1,700. In addition to the minimum monthly payments, ROHVA is responsible for its pro rata share of real estate taxes and operating expenses under the lease agreement.
