The Harold Alfond College Challenge is a new program that will provide a \$500 grant to every Maine baby to start a college investing account and help Maine families plan for a child's college education. This \$500 grant is for Maine babies born on or after January 1, 2009. Every Maine resident baby is eligible. The Foundation has a contractual arrangement with the Finance Authority of Maine (FAME) for which FAME will accept, invest and manage the scholarship funds as Section 529 plans. As accounts of participating children become eligible, FAME will disburse the account funds for eligible qualified higher education expenses.
