We have a committed and proven track record of providing primary and preventive care to the low-income, uninsured people, with the goal of improving access to care and health outcomes, and reducing unnecessary ER use. The Organization's services include primary and preventative care, in-house labs, digital x-ray, vaccinations, diabetes education, access to donated medications, treatment of acute and chronic illnesses, and on-site medical specialties including cardiology, mental health counseling, endocrinology, ophthalmology, vascular, and more.
