Forward MT Foundations (FMF) mission is to educate, engage, and organize young Montanans to shape their democracy to improve their lives and the lives of fellow Montanans. We believe that if more young people vote and advocate civically for public policies that reflect their values, a more supportive climate will be created to advance public policies that better the lives of young people and all Montanans. This change will happen faster if more young Montanans have the leadership skills and training to be effective civic advocates. To accomplish our mission and our theory of change, we focus on non-partisan voter registration, leadership development, issue advocacy and community education, and non-partisan voter mobilization of young Montanans. In 2016, FMF graduated 25 college interns, 7 high school interns and 9 fellows from our leadership development programs. These programs were geared towards high school and college-aged students. We worked with the University of Montana and Montana State University to host these students, in exchange for class credit. Students participated in weekly classes, a field program, and led a final project. FMF hosted their 2nd Annual 25 under 25 event, recognizing 25 inspirational young leaders from across the state. Leaders were selected based on their innovation, bravery, commitment to their local community, and ability to move Montana forward on issues like the environment, equality, election reform, health care, economic justice, and education. FMF hosted 13 educational events focused on increasing public awareness about issues important to young Montanans including, LGBTQ equality, public lands, renewable energy, student debt and election reform. FMFs voter registration efforts are driven by peer-to-peer engagement and conducted through face-to-face conversations with volunteers. This year they hosted voter registration drives in Bozeman, Billings, Dillon, Great Falls, Helena, Kalispell, Livingston, and Missoula. FMF celebrated National Voter Registration Day on four campuses-- University of Montana (Missoula), Montana State University (Bozeman), Montana State University- Billings (Billings), and University of Montana- Western (Dillon). They engaged with local businesses, student governments, fraternities and sororities, organizations like League of Women Voters and the Girl Scouts to host voter registration stations and events at coffee shops, breweries, and community health centers. 84% of individuals registered were voters 18-34 years old, unmarried women or people of color. FMF worked with volunteers to engage in voter mobilization or Get out the Vote (GOTV) efforts in Missoula, Bozeman, and Billings. Volunteers and staff made 18,252 calls and sent 3,589 texts to ask their peers to vote and answer questions about the logistics of voting. They held 42 events and call nights to do peer to peer outreach during the General Election. They held a themed call night event for Halloween, a Galloween. Witches calling Witches event. They also co-sponsored 5 candidate forums in Gallatin and Lewis & Clark counties.
