

Community ReUse Centers: We now have two centers open daily. Donation of goods and materials are accepted, processed, and resold back into the community at both centers, making it convenient for people on either side of Ithaca. Pick-up and delivery, and computer repair services are also available. Annual sales exceeded 4,250 furniture & appliance items, over 7,500 computer and electronic items, over 40,000 household items, plus over 6,500 tools & hardware items were all sold back into the community and diverted from landfills.

The Centers had more than 36,000 visitors and received an estimated 161 tons of material donations. The Center received over 34,000 visits and more than 175 tons of material was received in donations. Sales of donated products provided over 54% of the revenues of the centers.

4b (Code:) (Expenses \$ 46,519. including grants of \$ 0.) (Revenue \$ 18,454.)

Deconstruction Program: 12 projects were performed ranging from bathrooms to building removals. Deconstruction is performed using hand tools in order to salvage a maximum amount of material. Materials in good condition collected from deconstruction projects are resold to the community. Materials are also accepted by donation. In 2015 sale of reusable building materials increased 2.9% to more than 12,295 building material items in addition to nearly 13,000 units of lumber.

Community Education and Outreach: The ReSET job training program, with curricular tracks in construction, technology, and retail customer service served 16 participants. Participants in the Ithaca Fixers Collective repaired 137 household items and returned them to active use. The community reuse center template, which serves as an online tool to assist communities in creating their own independent reuse operations based on Finger Lakes ReUse model, had 89 registered users. Apprentice program provided 2,350 hours of employment for participants learning technology skills and 530 hours of employment for participants learning retail skills.
