During calendar year 2016 W2T completed or partially funded more than 135 rural community water projects in Ethiopia, Tanzania and Uganda. These projects include not only the physical construction of water projects, but also the training of a water council for the project and providing water, sanitation and hygiene training for all family units benefiting from the project. The water council is comprised of at least six elected members from the community: half women and half men. The water council is responsible for managing and overseeing the project, including sustainable maintenance by establishing a maintenance fund which is funded each each month by the family units using the project.
