 The purpose of the corporation is to provide a volunteer organization to support the Franklin County Metropolitan Parks (the "Metro Parks"), which is a separate political subdivision of the State of Ohio. The Metro Parks own and administer 23,500 acres comprising 14 parks in Franklin, Delaware, Union, Madison, Pickaway, Fairfield and Hocking counties. The corporation provides volunteers for Metro Parks events and establishes and coordinates its own events, the purpose of which is to raise public awareness and enjoyment of the parks. Corporation events and fundraising activities also assist with financially supporting various programs and improvements at the Metro Parks.
