An open free gathering at a local church, we invite those who are dying, their families and caregivers, those who are grieving the death of a loved one, those who work professionally in these fields, and anyone wishing to explore their own approaching death. Approximately 30 people attend this gathering. We are starting up a second group in a neighboring town. BOOTHS AND DISPLAYS at community events, fairs and events. Hundreds of people visited our booths this past year. JOURNEY WITH DEATH is a 4 part course taught in four different communities. Over 200 people attended these events. ROTARY CLUBS, CHURCHES, COMMUNITY ASSOCIATIONS were places we made educational presentations. Over 400 people have been to these presentations. DOORWAY INTO LIGHT'S STOREFRONT is an educational resource center that includes a lending library, a reference library, a bookstore, caskets and urns, as well as the services of end of life and bereavement counselors, a notary, trained hospice volunteers, social workers, a funeral director and support staff to help people get their paperwork in order.
