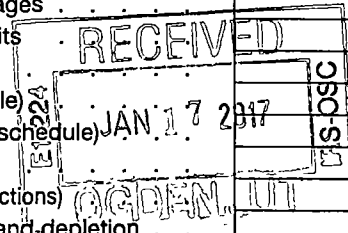

Firkin Press has no investments and operates solely from cash contributions and revenue from the sale of electronic book versions of the organization's literary magazine. In 2016 our average monthly total of contributions plus revenues was \$4106 and our average monthly expenses for carrying out our routine charitable activities were \$3954, a surplus of \$152 per month. Thus, from the \$2127 average end-of-month balance calculated for 2016, we consider a cash amount of \$1975 (\$2127 minus \$152) deemed held for our charitable activities.
