LIVEWELL COLORADO ("LIVEWELL") IS A STATEWIDE NONPROFIT ORGANIZATION COMMITTED TO INCREASING ACCESS TO HEALTHY EATING AND ACTIVE LIVING BY REMOVING BARRIERS THAT INEQUITABLY AND DISPROPORTIONATELY AFFECT LOW-INCOME COMMUNITIES AND PEOPLE OF COLOR. LIVEWELL FOCUSES ON POLICY, ENVIRONMENTAL, AND SYSTEMS CHANGES THAT ADVANCE OPPORTUNITY FOR HEALTHY BEHAVIORS WORKING WITH PARTNERS IN COMMUNITIES ACROSS THE STATE. LIVEWELL AIMS TO ENSURE THAT ALL COLORADANS LIVE IN ENVIRONMENTS WITH EQUITABLE ACCESS TO THE NOURISHING FOOD AND PHYSICAL ACTIVITY THEY NEED TO BE HEALTHY.

LOCAL INITIATIVES LIVEWELL COLORADO'S SCHOOL FOOD INITIATIVE (SFI) INVESTED OVER \$858K IN PROGRAMS TO TRANSITION SCHOOL DISTRICT KITCHEN OPERATIONS TO OFFER FRESHLY PREPARED STUDENT MEALS. SFI CONDUCTED SCHOOL MEAL ASSESSMENTS WITH RECOMMENDATIONS FOR SCHOOL DISTRICTS, PRESENTED CULINARY WORKSHOPS TO TEACH FUNDAMENTALS OF SCRATCH COOKING, AND DEDICATED A TEAM OF ON-SITE CHEF CONSULTANTS TO PARTNER WITH DISTRICTS THROUGHOUT THE SCHOOL YEAR IN CREATING AND IMPLEMENTING SUSTAINABLE CULINARY ACTION PLANS TO IMPROVE STUDENT MEALS. PROGRAM EVALUATION TOOLS WERE IMPLEMENTED TO ASSESS SUSTAINABLE CHANGES. SEE SCHEDULE O FOR ADDITIONAL INFORMATION. LIVEWELL COLORADO (LIVEWELL) CONTINUED TO EXPAND THE HEAL CITIES & TOWNS CAMPAIGN IN PARTNERSHIP WITH THE COLORADO MUNICIPAL LEAGUE TO ENCOURAGE MUNICIPALITIES TO PASS AND IMPLEMENT LOCAL HEALTHY EATING AND ACTIVE LIVING RELATED POLICIES. THE CAMPAIGN GREW TO ENCOMPASS 46 PARTICIPATING MUNICIPALITIES DURING THE YEAR, INCLUDING BRINGING ON NEW MEMBERS FROM CEDAREDGE, FORT COLLINS, MOUNTAIN VIEW AND NEDERLAND. LIVEWELL HOSTED THE FOURTH ANNUAL HEAL SUMMIT, WHICH BROUGHT TOGETHER MUNICIPAL AND COMMUNITY LEADERS TO LEARN AND SHARE BEST POLICY AND ENVIRONMENTAL PRACTICES TO CREATE HEALTHIER CITIES AND TOWNS. LIVEWELL'S COMMUNITY PARTNERSHIP PROGRAM FUNDED COMMUNITY COALITIONS WORKING ON HEALTHY EATING AND ACTIVE LIVING STRATEGIES AT THE LOCAL LEVEL. THE PROGRAM AWARDED \$1.59 MILLION IN FUNDING TO 16 LOW SOCIO-ECONOMIC COMMUNITIES ACROSS THE STATE WITH HIGHER OBESITY RATES, AND PROVIDED TECHNICAL ASSISTANCE AND OPPORTUNITIES FOR SHARED KNOWLEDGE AND COLLABORATIONS TO INCREASE SUSTAINABILITY, INCLUDING WEBINARS, ROUNDTABLE DISCUSSIONS, TRAININGS AND MEETINGS THAT PROMOTED INCREASED KNOWLEDGE OF HEALTHY FOOD, ACTIVE COMMUNITY ENVIRONMENTS, AND GRASSROOTS ADVOCACY. THE COMMUNITY PARTNERSHIP PROGRAM TARGETED TECHNICAL ASSISTANCE RELATED TO COMMUNITY ORGANIZING AND ENGAGING/EMPOWERING THE TARGET POPULATION.

COMMUNICATIONS AND OUTREACH LIVEWELL'S COMMUNICATIONS AND OUTREACH ACTIVITIES CENTERED ON BUILDING AND MOBILIZING CHAMPIONS FOR HEALTH, RAISING AWARENESS ABOUT BARRIERS TO HEALTHY, AFFORDABLE FOOD AND PHYSICAL ACTIVITY, AND ENCOURAGING ACTIONS THAT ADVANCED THE OPPORTUNITY FOR MORE COLORADANS TO HAVE ACCESS TO HEALTHY LIVING THROUGH A VARIETY OF DIGITAL AND TRADITIONAL COMMUNICATION AND MARKETING TOOLS (E.G. WEBSITE, FACEBOOK, TWITTER, EARNED AND PAID MEDIA, SPEAKING ENGAGEMENTS, AND MORE). LIVEWELL INSPIRED AND ENGAGED INDIVIDUAL AND ORGANIZATIONAL STAKEHOLDERS TO BECOME ADVOCATES FOR AND CHAMPIONS OF HEALTHY EATING AND ACTIVE LIVING AND WAS CENTERED ON HELPING ELIMINATE HEALTH DISPARITIES AND ADVANCING HEALTH EQUITY. SEE SCHEDULE O FOR ADDITIONAL INFORMATION. LIVEWELL DEVELOPED AND IMPLEMENTED TWO CAMPAIGNS TO ADVANCE POLICY AND ENVIRONMENTAL CHANGE TO SUPPORT LIVEWELL'S GOALS. BOTH CAMPAIGNS LEVERAGED AND SUPPORTED THE WORK OF LIVEWELL COMMUNITIES AS WELL AS OTHER PARTNERS, AND ALIGNED WITH PROGRAMMATIC AND POLICY WORK OF THE ORGANIZATION. LIVEWELL CULTIVATED AND ADVANCED ADVOCATES AND CHAMPIONS IN AUGUST 2016 WHEN LIVEWELL LAUNCHED A MAJOR PUBLIC AWARENESS CAMPAIGN CALLED "NO MORE 24" (WWW.NOMORE24.ORG) TO EDUCATE COLORADANS ABOUT THE STATE'S HEALTH PARADOX. COLORADO'S GREAT QUALITY OF LIFE ATTRACTS HEALTHY, EDUCATED ADULTS, YET IT STRUGGLES TO PROVIDE THAT SAME HEALTHY ENVIRONMENT FOR THE CHILDREN BORN AND RAISED HERE. THE GOAL OF THE 2016 PUBLIC EDUCATION CAMPAIGN WAS TO EDUCATE COLORADANS ABOUT THE HEALTH AND EDUCATIONAL BENEFITS OF PHYSICAL ACTIVITY FOR COLORADO KIDS, ULTIMATELY ENGAGING MORE ADVOCATES FOR REDUCING CHILDHOOD OBESITY. THE PUBLIC EDUCATION CAMPAIGN INCLUDED STATEWIDE DIGITAL ADVERTISING, OUTREACH TO COLORADANS AT COMMUNITY EVENTS, WORKING CLOSELY WITH PARENTING, SOCIAL JUSTICE, AND LATINO BLOGGERS, AND SHARING INFORMATION WITH ADVOCATES VIA EMAIL, SOCIAL MEDIA CHANNELS, AND PARTNER NETWORKS. LIVEWELL ALSO LAUNCHED A DYNAMIC AND INTERACTIVE WEBPAGE WHERE VISITORS COULD LEARN MORE ABOUT THE CAMPAIGN AND THE ISSUES IT ADDRESSED. THE PAID MEDIA PORTION OF THE CAMPAIGN CREATED CLOSE TO 23 MILLION IMPRESSIONS, WITH MORE THAN 109,000 PEOPLE ENGAGING WITH THE CONTENT IN SOME WAY (CLICKS, LIKES, SHARES, CONVERSATIONS WITH CANVASSERS, ETC.). TO DATE, THE CAMPAIGN HAS ATTRACTED 3,894 ADDITIONAL ADVOCATES TO LIVEWELL, WITH THE MAJORITY OF VISITORS COMING TO THE WEBSITE FROM FACEBOOK VIA MOBILE DEVICES. DURING THE NO MORE 24 CAMPAIGN, LIVEWELL'S WEBSITE TRAFFIC INCREASED BY MORE THAN 205 PERCENT AND AVERAGE TIME ON THE PAGE ALMOST DOUBLED. LIVEWELL ALSO SUPPORTED A SECOND SIGNIFICANT MEDIA CAMPAIGN AROUND THE DOUBLE UP FOOD BUCKS PROGRAM, AS REFERENCED ON SCHEDULE O UNDER 'NEW PROGRAM ACTIVITY'.

POLICY AND ADVOCACY LIVEWELL SUCCESSFULLY ENSURED THE DEFEAT OF A PROPOSAL TO REMOVE THE PHYSICAL EDUCATION GRADUATION REQUIREMENT IN DENVER PUBLIC SCHOOLS. LIVEWELL CRAFTED STATE LEGISLATION TO MAKE IT EASIER FOR COLORADO FARMERS TO SELL THEIR PRODUCE TO SCHOOLS AND SNAP CUSTOMERS, FOR INTRODUCTION IN THE 2017 LEGISLATIVE SESSION. LIVEWELL ADVOCATED THAT ANY INCREASED FUNDING FOR TRANSPORTATION IN COLORADO INCLUDE DESIGNATED RESOURCES FOR BIKING AND WALKING INFRASTRUCTURE. LIVEWELL HOSTED THE SEVENTH ANNUAL DAY AT THE CAPITOL, INCLUDING A HEALTHY MEET-AND-GREET LUNCH AND A PANEL OF COMMUNITY PARTNERS WORKING ON INCREASING ACCESS TO HEALTHY FOOD. SEE SCHEDULE O FOR ADDITIONAL INFORMATION. LIVEWELL CONTINUED TO SUPPORT THE DEVELOPMENT OF THE COLORADO FOOD POLICY NETWORK (COFPN) AND ITS LEADERSHIP COUNCIL. THE COFPN BROUGHT TOGETHER THE 18 LOCAL FOOD POLICY COUNCILS FROM ACROSS THE STATE TO PROMOTE HEALTHY, COMMUNITY-BASED, ECONOMICALLY VIABLE FOOD SYSTEMS IN COLORADO THAT ENSURE ALL RESIDENTS HAVE ACCESS TO AFFORDABLE, NUTRITIOUS FOOD. CORE AREAS OF FOCUS INCLUDED BUILDING THE CAPACITY OF LOCAL FOOD SYSTEMS COALITIONS TO AFFECT POLICY CHANGE AND ADVANCING STATE LEVEL POLICIES, INVESTMENTS AND STRATEGIES THROUGH A COLLECTIVE APPROACH. LIVEWELL WORKED WITH A COALITION OF PARTNERS TO ADVOCATE THAT THE SALE OF DIET SODA BE PROHIBITED IN COLORADO SCHOOLS, UNSUCCESSFULLY CONVINCING THE STATE BOARD OF EDUCATION TO MAINTAIN HIGH HEALTHY SCHOOL FOOD STANDARDS BUT ENHANCING AWARENESS ABOUT THE ISSUE THROUGH THE PASS PROJECT (POLICY ASSISTANCE AND STRATEGY SUPPORT). LIVEWELL SUPPORTED LOCAL PARTNERS IN SUCCESSFULLY PASSING POLICY CHANGES IN LOVELAND AND LONGMONT AND CONTINUED ADVOCATING FOR A POLICY CHANGE IN DENVER TO BENEFIT THE WESTWOOD NEIGHBORHOOD. THE PROJECT PROVIDED TARGETED TECHNICAL ASSISTANCE FOR STRATEGIZING, PASSING, AND IMPLEMENTING COMMUNITY-BASED, LOCAL-LEVEL HEAL POLICY INITIATIVES. LIVEWELL SUBMITTED COMMENTS ON A PROPOSED FEDERAL RULE FROM USDA FOOD AND NUTRITION SERVICE REGARDING ENHANCING RETAILER STANDARDS FOR SNAP.
