Thousands of people were impacted by these efforts. MADALA also carried out ministry evaluations, MADALA officers traveled to West Africa to help the National Christian Foundation strengthen partnerships and evaluate needs of local churches, ministries and organizations. The executive director was employed to evaluate and supervise projects funded in West Africa by MADALA. MADALA maintained an office and performed administrative work in order to evaluate and responsibly give to the ministries of West Africa.
