The Apparent Project has developed a program to train Haitians in bead making, jewelry making, sewing and other artistic trades. Seventeen to twenty assistant managers and artisans completed basic training in typing, Rosetta Stone English, Excel and Word. These skills gave them the ability to provide reports for management purposes. Shipped over 150,000 items for a 2016. This resulted in approximately 250-275 Haiti artisans being employed throughout the year.

Volunteer artisans trained Haitian artisans in screen printing, pottery and glass bead making. Screen printing training resulted better quality screen printing and increase requests for items. Pottery training provided additional skills to enhance their ability to create a larger variety of products.

20-25 "at risk" infants and toddlers were cared for Monday through Friday throughout the year, enabling the parents to work.
