Free education, clothing, and school supplies were provided to children in the slum areas. Bore wells were dug to provide fresh water to neighborhoods. Reverse osmosis systems have also been provided. Books in various translations were provided. Bicycles and motorcycles were given to pastors to assist with travel. Churches were constructed. Pastors were provided with training and equipment, including computers. Clean blankets were provided to the poor. SIF's outreach is in five states in India: Andhra Pradesh, Karnataka, Odisha, Tamil Nadu and Telangana.**
