The Joshua Collingsworth Memorial Foundation (JCMF) experienced many accomplishments during 2016. The foundation was honored with the 2016 Community Lifesaver Award from the National Drowning Prevention Alliance on behalf of their involvement with Families United to Prevent Drowning. The foundation was honored to partner with USA Swimming Foundation's Make a Splash Initiative at the 2016 Olympic Swim Trials with a booth and presentation schedule in the Splash Zone at Century Link Center. To date, over 200,000 books have been distributed to children across the U.S. and worldwide. The sixth annual Otter Spotter Day was a success with hundreds of volunteers in over 40 U.S. states and 5 countries participating in the social media event to raise awareness for water safety and drowning prevention. Furthermore, the foundation has continued to expand the Rotary Josh the Otter Water Safety and Literacy Project with Rotary International. Over 120,000 "Josh the Baby Otter" books have been distributed to children worldwide through this partnership.
