 Health and Mission Programs Hosted two missions trips that served over 2,500 patients. Services during the mission included medical, dental, eyeglass clinic, small medical procedures, pharmacy medications and vitamins for all. The mission also held training talks for patients on preventative healthcare, like diabetes, high blood pressure and hand washing. As well 3,500 children participated in childrens programs. Other health projects included adding gutters and tanks for a church to harvest rain water, adding tanks and a tank cover for residents in new communities to have closer access to clean water.
