THEY INSTALLED EDUCATIONAL SIGNS IN THE QUINNIPIAC MEADOWS NATURE PRESERVE, INCREASED THE NUMBER OF EDUCATIONAL OFFERINGS AND THE DIVERSITY OF THEIR PARTICIPANTS, AND CONDUCTED RESEARCH FOR ESTABLISHED EDUCATIONAL PROGRAMS UTILIZING NHLT'S OYSTER BED, AND CONDUCTED RESEARCH TO FURTHER THEIR LAND ACQUISITION PROGRAM
