At our retreat center (Wonderwell) we offered training in Tibetan Buddhism through 1) Buddhist meditation retreats that ranged from one weekend to one month, 2) a weekly meeting of meditation, practice, and Buddhist study, 3) "Dharma Sunday" - a monthly all day program of meditation, practice, and Buddhist study, and 4) the "margha program" - a formal, multi-year study program in Buddhist meditation with over 100 students. These were all overseen by "Lamas" (teachers/ministers) trained in the Tibetan Buddhist tradition. We also did several other retreats at other locations.

In Cambridge MA we pay for the use of a local church building for a weekly meeting of meditation, practice, and Buddhist study. We also did two weekend retreats in Cambridge.
