

**Part 1. Q2 -** Third Millennium Alliance's (TMA) Executive Director lives full time in Ecuador. In addition, two of the organization's Program Directors and the three Co-Founders visit TMA's administrative office in Quito and TMA's ecological project (the Jama-Coaque Ecological Reserve) on a rotational basis. All six of these individuals provide monitoring and auditing of TMA's funds internationally.

**Part I. Q3-1 (d) & Q3-1 (e)** 100% of TMA's funding and expenditures are to carry out the mission of the Reserve. A more complete description of TMA's mission and program services are described in TMA's Form 990 Part III and in Schedule "O".

**Part II. Q1(d)** To have "local" (i.e., Ecuadorian) people assist international researchers and interns to carry out the mission of the Reserve. Key aspects of TMA's/ the Reserve's mission and program services are to restore and maintain the Reserve's 1,400 acres of rainforest in Manabi Province, Ecuador, conduct rainforest research, protection of wildlife, including rare species, sustainable development, agroforestry, and provide local community outreach to three towns adjacent to the Reserve.

**Part II. Q1 (e)** In 2014 TMA made \$47,500 grants to an Ecuadorian organization known as "Grupo Ecologico Jama Coaque" ("GEJC") for full-time, on-the-ground services and assistance in carrying out the mission and program services of the Reserve. Services provided by GEJC personnel include assistance to international researchers and interns, menial labor for Reserve maintenance, housing, food services. In addition to TMA's grant to GEJC for assistance in managing/maintaining the Reserve TMA had \$56,030 of direct expenditures to carry out the Reserve's mission.

**Part II. Q1 (i)** Ecuador uses the US dollar as its currency. All grant funding to GEJC from TMA was in US dollars paid via wire transfers from TMA's checking account with Bank of America in the US to GEJC's account at Banco Pichincha, Ecuador's largest bank.

**Part I Line 1 & Part III Line 1 - Third Millennium Alliance ("TMA") owns 1,400 acres of rainforest in Manabi, Province Ecuador, within several miles of the equator, known as Jama-Coaque Ecological Reserve (the "Reserve"). The mission of TMA is to protect one of the last primal rainforests in coastal Ecuador, including its wildlife and rare species of fauna, and the watershed of the Camarones River, which runs through the Reserve, and also serves three adjacent indigenous Ecuadorian communities with a combined population of 2,000 people. TMA/the Reserve also serves as a platform for research on coastal rainforests, sustainable development, agroforestry, and rainforest conservation. Approximately 50 unpaid volunteer international researchers, students, and interns visit the Reserve at one time or another throughout the year to carry out TMA's/the Reserve's mission. Due to the Reserve's remote location researchers and interns require on-site living accomodations. "Grupo Ecologico Jama-Coaque" ("GEJC"), an Ecuadorian social services and support orgnaization, assists TMA/the Reserve in carrying out its mission, which also includes some community outreach to local indigenous communities, notably the adjacent village of Camarones.**

**Part I Lines 8-19 In tax year 2015 TMA had total revenues of less than \$200,000, thus filed Forms 990-EZ, and does not have the detail available for "prior year" figures in TMA's 2016 Form 990.**

**Part III Line 2 - In 2016 TMA expanded the long-running volunteer and intern program (described in Part III Line 4a) to include university groups participating in an international learning experience in Ecuador. This inclusion of international student groups significantly increase the number of students, researchers, volunteers, and interns that spent time in the Reserve studying and working in the area of sustainable food production and Tropical Ecology.**
