Part 1, Line 8, Other revenue. This \$3638 consists of mostly refunds and reimbursements. We had a supporter who was traveling to Peru, and we purchased their flight so they reimbursed us. There is also a refund from our payroll company. We also recieved around \$200 in reimbursements from our Peruvian partner for expenses made on their behalf.

Part 1, Line 10, grants. This \$132,684 consists of grants to support artisan women's business and craft skills development made to our partne in Peru. It also includes small grants to Yachay Wasi, a daycare for working moms in Peru, and FINCA, an artisan cooperative whose scholarship fund we supported.

Part 1, Line 16, Other expenses. This \$10069 consists of meetings, conferences, supplies, social media advertising, bank fees and business registration fees among other misc costs.

Part 1, Line 20, Other changes in net assets. This \$1493 consists of rounding errors made when completing the last return. It was incorrectly rounded to the 100s which made the totals slightly inaccurate.
