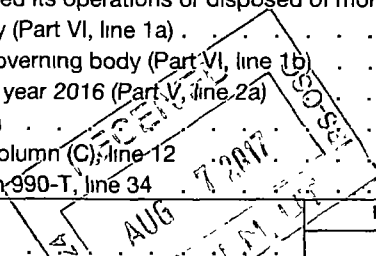

Our primary program service is to rescue dogs that are scheduled for euthanasia at high kill California shelters We arrange to transport the dogs to the Bay Area, provide necessary vet care, training, and rehabilitation, and house them in foster care until suitable permanent homes can be found Occasionally we rescue dogs that cannot be adopted due to medical or behavior issues and we provide sanctuary for these dogs for their natural lifespans In 2016 we rescued and placed more than 650 dogs.

Our secondary program service is to increase public awareness of the animal overpopulation problem and to rally people to join our cause. We do this through maintaining a Facebook page and publishing information on shelter dogs to our community of dog-loving followers We also hold many events through the year such as barbecues, happy hours and charity auctions that raise funds to support our rescue dogs and help us disseminate information about California's high kill shelters to the general public Finally, this year we recruited over 60 new volunteers who assist us with placing our rescue dogs and our campaign to educate the public about California's animal overpopulation problem
