The mission of the Women's Foundation of Mississippi is to provide economic security for women in the state. The Foundation does this by cultivating social change through research, advocacy and public education/awareness efforts, and a competitive grantmaking process that awards grants in the foundation's focus areas of Access to Opportunities, Planned Pregnancy, and Better Futures, a Two Generation Approach. The Foundation is committed to helping Mississippi's women and girls transcend the state's dire social and economic barriers. The foundation seeks to create long-term opportunity for personal stability and stronger families. Women have a greater opportunity for upward mobility and economic stability when they can plan for pregnancy, earn a degree or receive relevant job related training, and pursue a viable career with a livable income. Key activities and accomplishments by the Foundation in 2016 include:

- Commissioning research on the topic of what constitutes a quality job in Mississippi and the availability of those jobs to women in the state
- Convening a meeting of community college grantees and funders to share information with each other and disseminate best practices
- Continued maintenance of the Fact Not Fiction website to provide awareness to teenagers and their parents on sex education. The website targeted teens in Mississippi with messages that would lead them to the resource based on the rates of teen pregnancy and STI's in their area. We continued to work with nurses to provide medically accurate fact-based information to questions submitted via the site.
- A review of the organization's brand was conducted, resulting in a new logo and initiation of a new website that will improve interactions between the organization and the public who wish to seek additional information or engagement opportunities.
- Collaboration to execute an awareness activity with TedEx Jackson to engage thought leaders and share information with the public.
- Ongoing fundraising efforts that included the creation of a three-year fundraising campaign.
- Began the process to define advocacy approach and determine focus areas where the foundation can have the greatest impact in improving economic security for women.
- Offered internship opportunities to young women to develop their own skills while also assisting the foundation in meeting daily and annual goals.
- Participation in national funding network groups to collaborate on activities and fundraising opportunities.
- Ongoing management of an annual grants program including public announcement of the opportunity, review of applications both in writing and in person, review of grantee reports, evaluation of grantee projects, and ongoing communication with grantees. We also enhanced grantmaking through a technology platform that allows us to better manage the overall process.
- Awarding grants to 16 organizations across the state in the three focus areas, totaling \$785,000.
