Survey & Issue Research - CLI (Charlotte Lozier Institute, d/b/a of filing organization) completed first-of-its-kind research on the utilization of mobile pregnancy centers as components of pregnancy help services in the United States. The research covered service experience and best practices for these unique providers, and results were shared with five national pregnancy center network organizations for use in their strategic advice and operation activity. CLI also continued research in 2016 on the impact of pro-life laws on abortion rates and maternal health in Texas and elsewhere in response to published studies suggesting changes in family planning funding led to adverse outcomes for maternal health.

Stem Cell Website-CLI continued its program to educate the public and policymakers on the significant achievements, as well as benefits to patients, of adult stem cells and other stem cells derived without harm or destruction of human beings, including embryos. Adult stem cells continue to provide the gold standard for patient treatments, and the only validated health benefits, compared to the utter lack of therapeutic benefit achieved by use of embryo-destroying approaches and use of fetal tissue. CLI efforts include written publications and fact sheets, policy engagement, public testimony, media interviews, and further development of an educational website, stemcellresearchfacts.org, which documents adult stem cell successes through personal stories about this exciting, growing area of medicine.

Special Project Writing - In addition to its other program emphases, CLI supports individual ad-hoc writing and research projects on various topics in bioethics and sanctity of human life issues. These projects include policy papers, fact sheets, and commentaries for publication on CLI's web site or in the general media (print or electronic), blogs, and other formats. Writers are drawn from the CLI's list of expert advisors or others with special skills but no official role with CLI. In 2016 these papers included a review of state laws governing the disposal/interment of human remains from legal abortion activity, a study of the impact of sex selection abortion on the female unborn, an analysis of the life-saving impact of the federal Hyde Amendment limit on Medicaid financing of abortion, and a report on attacks on conscience in the area of health care provision.

Defunding Planned Parenthood-Debates continue to swirl around the use of public money to support women's health programs that feature elective abortion, activity Congress and most states have declined to finance or subsidize for decades. CLI analyzes trends in pregnancy and abortion data and federal and state budgeting, as well as private insurance practices to evaluate the impact of changes in women's health spending on patient options and decision-making. The goal is to ensure that public funds support best practices in women's health and reduce rates of abortion in vulnerable populations.

Outreach - As a research and education organization, CLI seeks to complement work being done by existing organizations, to create collaborative relationships and projects wherever possible, and to disseminate its findings and recommendations to a broad national, local, and international policy community. In 2016 CLI participated in many collaborations, continuing to cosponsor web sites with Alliance Defending Freedom and other nonprofits on community health centers and with Family Research Council identifying federal exchange health plans that cover elective abortion. Attendance by staff members at events on policy issues and research topics is central to the mission of the fund. Staff members attended and addressed events related to the organization's mission in Washington, D.C., Virginia, Georgia, Indiana, Kansas, Colorado, Delaware, and Illinois.

Web Development - In 2016 CLI maintained or made major contributions to four websites: lozierinstitute.org, our mainstay, ObamacareAbortion.com, which tracks each plan on the federal-state health insurance exchanges and identifies elective abortion coverages, stemcellresearchfacts.org, a major resource on stem cell research in the United States, and getyourcare.org, which provides interactive information on alternatives to Planned Parenthood via community health centers across the United States. These sites continue to be routinely cited by policy makers for their relevance to government funding in controversial areas of public budgeting.

Obamacare/Health Care Alternatives - CLI continued in 2016 to make available information analyzing the impact of federal and state insurance exchanges on subsidies for plans that cover elective abortion. In addition to identifying policy remedies, CLI worked with Family Research Council and co-researched and promoted ObamacareAbortion.com, a resource to allow the public to examine whether premium-subsidized plans in their state include this objectionable coverage before they decide to buy. CLI also continued to provide commentary to national media about the difficulty of identifying these coverages despite the clear commands of the Affordable Care Act to provide disclosure and transparency regarding this coverage.

Pregnancy Center/Abortion Data Collection - CLI developed a rating system for the 50 states and the District of Columbia using objective measurements of each jurisdiction's thoroughness, timeliness and ease of use for in-state data about abortions performed on residents and non-residents. The rating system, included in a CLI special report, identified a number of states that publish current and accessible data and many more where the information gathered and published is subpar. The rankings drew national attention and have helped to spark widespread debate about ways to upgrade the U.S. abortion reporting system, including federal reforms, state reforms, legislative incentives, and the creation of abortion registries similar to those of other nations.

Fetal Tissue Trafficking-The nature and extent of trafficking in fetal tissue for scientific purposes has been the subject of renewed scrutiny in Congress as a result of media reports alleging profit-making in the abortion industry and alteration of abortion methods to meet procurement requirements rather than serve women's health. CLI has supported information-gathering and policy research with respect not only to issues covered in national media but the underlying question of the ethics and utility of fetal tissue harvesting, transfer and research, with the goal of making ethical and scientifically sound recommendation for national and state policy makers.

The papers examined, among other topics, the impact of late-term abortion for fetal anomaly on women's mental health. CLI also supported expert testimony before legislatures across the U.S. on the reality of pain in the unborn at this stage of pregnancy and earlier, as well as other types of normative evidence supporting the separate humanity of the child in the womb (e.g., fetal surgery). Witnesses appeared in Minnesota and Washington, D.C. (U.S. Congress). The Education Fund contributed to a movie being made to expose Gosnell and the atrocities that occurred in his abortion clinic in Philadelphia, PA.

Media & Communications - CLI continued its strong presence in national and specialized media in 2016. CLI publications were covered and/or CLI data and spokespeople were quoted or cited on EWTN News Nightly, The Washington Examiner, Nature, Politico, MD Monthly and many more. Op Eds/Blogs written by CLI staff and associates appeared in The Wall Street Journal, The Daily Caller, The Dallas Morning News, TribTalk (Texas), The Daily Signal, and National Review Online. CLI also maintained active lists of interested members of the public, including donors, policy allies, and interested citizens. CLI communicates with each of these constituencies through its participation in a quarterly newsletter co-published with SBA List, print copies of its major reports, commentaries, fact sheets, and tweets, Facebook notices, and email alerts announcing the release of new material.
