In 2016, we accommodated more students in our daycare, kindergarten, preparatory, primary, secondary education and technical programs, increased the number of kids receiving university and technical degrees, and promoted the physical, mental, spiritual and social development of children to perform individually, collectively, and contribute to the welfare of society.
