Advocacy HIP amplifies the use of public-health research, expertise, framing, and communications to support targeted campaigns and movements. In 2016 based on our research, we spoke at several press conferences and public hearings, produced videos, fact sheets, and infographics to bring a health lens to policy debates, and organized other health professionals to make public statements.
