FINANCIALLY SUPPORTED THE WORK OF APUFRAM IN HONDURAS, PROVIDING ALL LEVELS OF EDUCATION, HOUSING, FOOD, CLOTHING, MEDICAL, PSYCHOLOGICAL AND DENTAL CARE AND SPIRITUAL GUIDANCE TO 700 YOUNG PEOPLE IN EXTREME POVERTY, INCLUDING 240 INDIVIDUALS IN TEN BOARDING FACILITIES. THE ORGANIZATION ALSO ASSISTED IN MAINTAINING FOUR HOUSES FOR UNIVERSITY STUDENTS. ADDITIONALLY, APUFRAM PROVIDES FINANCIAL SUPPORT TO SEVEN PRIESTS WHO EXTENSIVELY TRAVEL TO MINISTER TO THEIR PARISHIONERS IN RURAL PARTS OF HONDURAS. APUFRAM ALSO FINANCIALLY SUPPORTED THE WORK OF EIGHT LAY PASTORAL WORKERS MINISTERING IN RURAL COMMUNITIES. APUFRAM CONDUCTED A CAMPAIGN TO ASSIST IN THE REOPENING OF THE SAN BERNARDINO DE SIENA BOARDING FACILITY FOR PRIMARY AGE BOYS IN THE COMMUNITY OF LA BARCA. IN ADDITION TO PROVIDING NECESSARY PROJECT FINANCIAL ASSISTANCE, APUFRAM SPONSORED TWO GROUPS OF U.S. VOLUNTEERS TO ASSIST THE COMMUNITY WITH RENOVATION AND FURNISHING OF THE FACILITY AT LAS METALIAS AS A GUEST HOUSE AND RETREAT CENTER FOR THE PROGRAM ACTIVITIES.
