Due to over-crowding at the county animal shelter, FOTAS worked aggressively to transport as many adoptable animals as possible to no-kill shelters. The transfer program includes an extensive network of volunteers who foster dogs until they are old enough or healthy enough for transport. In 2016, FOTAS facilitated the transfer of 1,382 adoptable dogs and cats to no-kill shelters

4b (Code:) (Expenses \$ 46,725 including grants of \$ 46,725) (Revenue \$ -0-)Shelter operating needs--

FOTAS supplemented the county's shelter budget by funding numerous items for hundreds of animals such as preventative and rehabilitative medical care; heartworm treatments; flea treatments; food; toys, collars, and leashes, etc. FOTAS funded the Playing for Life program which allows dogs to play in supervised groups to reduce stress and improve social skills and also veterinary assistant courses at a local technical college for shelter staff. FOTAS pays for an extensive advertising program to alert area citizens to the many and varied pets available for adoption at the county shelter and also the fees for Veterans if they adopt a shelter animal.

FOTAS paid for grading all existing play yards to improve drainage and funded one new play yard and four exercise pens for the intake wing of the county shelter. FOTAS funded 30 new kennel decks; tops for adoption kennels; cement walkways and two new gates. FOTAS replaced the air conditioner in the cat adoption house and added a new commercial dishwasher to better sanitize animal food dishes

Our strategy is to improve shelter facilities to reduce sickness and injury to animals, transport to no-kill shelters many adoptable animals that would otherwise be euthanized for lack of available homes, and fund spay and neuter surgeries to reduce the number of unwanted animals.
