The vision of 1040i is to transform the lives of people in need by fighting pain and suffering in the most isolated places on our globe. The primary focus is centered on health and education needs between 10 degrees and 40 degrees north of the equator spanning across North Africa and the Middle East.

Projects and Trips: This is 1040i's largest program. In 2016 1040i conducted 3 trips to Cote d'Ivoire. The first trip in February had 69 North American volunteers. The medical team, which included 5 surgeons, performed 94 surgeries, distributed 280 pairs of glasses and performed 47 cataract surgeries. The education team built a dormitory for middle school students in Nioman, a small village in north Cote d'Ivoire, and distributed 2,500 backpacks to local students. The second trip in June consisted of 17 volunteers and was named Kidzfest. During this trip the team tutored children at the school, conducted a kid's camp for 250 children, and distributed 3,500 pairs of shoes. The third trip, also in June, was made up of 14 volunteers. This team prepared the school classrooms for the upcoming school year, and gave 15 people the ability to walk by providing them with prosthetic legs.

Rejoice Bilingual Academy: In 2014, 1040i enrolled students for first and second grade at its bilingual academy in Tanda, Cote d'Ivoire with the goal to change poverty through education. This academy instructs in both French and English, now from 1st grade through 4th grade. Upon high school graduation students will receive a dual American and Cote d'Ivoire diploma. 1040i owns the academy facilities, and oversees the staffing and operations of the academy. The academy was completed and began operations in 2014. The academy will instruct in normal primary and secondary educational areas, as well as technology.
