WE ACCOMPLISH OUR MISSION BY PROVIDING SERVICE MEMBERS AND THEIR FAMILIES FREE SPORTS EQUIPMENT, FINANCIAL GRANTS TO OFFSET REGISTRATION FEES, SKILL DEVELOPMENT CAMPS, AND PRO SPORT TICKETING FOR A SPECIAL NIGHT OUT BEFORE OR AFTER A DEPLOYMENT. TO DATE, THE ORGANIZATION HAS PROVIDED OUR NATION'S HEROES WITH OVER 20,000 PRO SPORTS TICKETS, 3,300 SETS OF ATHLETIC EQUIPMENT, SENT OVER 1,800 KIDS TO DEVELOPMENT CAMPS, AND ASSISTED WITH OVER 500,000 IN FINANCIAL AID TO SERVICE MEMBERS STRUGGLING WITH THE HIGH COST OF YOUTH SPORTS.
