Operation North Pole The Organization hosts a fantasy trip to the North Pole for approximately 75 families who have a child battling a life threatening/terminal illness. The trip includes an overnight stay at a local hotel, a ride on a specially holiday themed "wrapped" Union Pacific Metra Commuter train, a visit to Santa's Winter Wonderland, which is a 28,000 sq. ft. decorated banquet facility located at the Donald E. Stephens Convention Center in Rosemont, IL and finally, holiday presents for all the good little boys and girls aged 12 and younger in the family. Approximately 165 children aged 12 and younger received gifts valued at \$300.00 in addition to other gifts for the rest of the family unit Red Cross Coat Program. Each year, the American Red Cross of Chicago and Northern Illinois responds to over 750 incidents covering the 21 northern counties of Illinois during the months from September to April. During this time over 3,000 adults and children are left homeless due to a house fire. Operation North Pole has partnered with the Red Cross to provide 3,000 new winter coats to those who have been displaced from their home due to fire or other natural disaster. Additionally, ONP annually provides a local elementary school with a high student population on free/reduced lunch with a new coat. In 2016 ONP provided over 3,300 coats to people in need.
