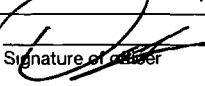

The KEA Educational Foundation's specific purposes are to provide scholarships for students and to make grants and donations for educational purposes to charitable entities.

The KEA Educational Foundation generated \$47,078 in funds in 2016. This revenue was derived from two sources: 1) Contributions from Kodiak Electric Association that either elected to round up their monthly utility bill as a donation or elected to donate their retired Capital Credits to the KEA Educational Foundation. These donations totalled \$29,056 (not listed above). 2) Investment income of \$18,022 was generated in 2016 (listed above).

Kodiak Electric Association has awarded 334 scholarships since 1990, totalling \$697,000. In 2016, 15 scholarships totalling \$37,000 were awarded. The KEA Educational Foundation will fund these scholarships into the future, utilizing funds generated through contributions and investment income.
