GNC KIDS CLUB: Through the Kids Club program over 6000 slum children in Delhi area were taught health and hygiene, build leadership qualities and work in teams. They were taught inspirational stories from the scripture and mentored by local staffs and volunteers to ward off bad influence and be exemplary children in their neighborhood. We see vast improvement in studies and all aspects of these children and received extremely positive feedback from their parents.

Church Planting. Organization was successful in helpin volunteers to teach about the gospel of Jesus Christ. Under this program, volunteers went out to villages to make disciples and provide church service where there is no church or people cannot go to church. Huge demand in Western Odisha for church planters.
