LAKESHORE COMMUNITY FOUNDATION, INC. IS A TAX EXEMPT PUBLIC CHARITY ORGANIZED AND OPERATED PRIMARILY AS A COLLECTION OF PERMANENT FUNDS TO BENEFIT SHEBOYGAN AND MANITOWOC COUNTIES. THE FOUNDATION RECEIVES, ADMINISTERS, AND DISTRIBUTES GIFTS FROM INDIVIDUALS AND ORGANIZATIONS FOR THE LONG TERM BENEFIT OF THE COUNTIES IT SERVES. DURING 2016, THE FOUNDATION ADDED 4 NEW FUNDS TO ITS PORTFOLIO FOR A TOTAL OF 48 FUNDS WITH AN AGGREGATE MARKET VALUE OF \$26,362,865 AT YEAR END. THE COMPOSITION OF FUNDS BY TYPE AT YEAR END 2016 WERE AS FOLLOWS: AGENCY FUNDS - 17, DESIGNATED FUNDS - 11, DONOR ADVISED FUNDS - 14, FIELD OF INTEREST FUNDS - 5, UNRESTRICTED FUNDS - 0, LAKESHORE FUND - 1. AVERAGE FUND SIZE WAS \$549,226. ANNUAL GROWTH IN GIFTS TO NEW AND EXISTING FUNDS WAS \$6,112,617. THE FOUNDATION MADE 99 GRANTS DURING 2016 TOTALING \$1,791,902. THE COMPOSITION OF THOSE GRANT DOLLARS INCLUDE \$256,786 IN AGENCY GRANTS, AND \$1,535,116 IN GRANTS FROM THE FOUNDATION'S DESIGNATED, DONOR ADVISED, AND FIELD OF INTEREST FUNDS. SINCE THE FIRST FUND WAS ESTABLISHED IN MAY 2011, THE FOUNDATION HAS MADE 346 GRANTS WITH A CUMULATIVE VALUE OF \$6,380,649.
