28 Engaging Community As a network of more than 350 partner organizations (businesses, nonprofit organizations, faith communities, educational institutions, and local government) and hundreds of individual volunteers, the Coalition provided grassroots leadership, inspiration, resources, and opportunities for collaboration in working on sustainability issues. The Coalition encouraged community involvement and interaction by inviting the entire community to its quarterly meetings, where attendees had the opportunity to network and share information about sustainability issues, and numerous presenters among the partner organizations and 12 action teams presented their sustainability accomplishments. The Coalition expanded and deepened its collaborative efforts with partner organizations, including the creation of an internship program with Oregon State University (OSU) students. In March 2016 the Coalition hosted its annual Sustainability Fair and Town Hall event, which was attended by more than 500 people, to continue highlighting the sustainability efforts of the community and to prompt discussions among the participants in small groups on local sustainability matters. The Sustainability Fair featured local food, lively music, and more than 50 hands-on sustainability exhibits. Featured speakers at the Town Hall event were keynoters James Reismiller and Cassandra Robertson, who presented "Ideas and Inspiration from Germany's Culture of Sustainability." 30 Fostering a Secure Local Food System, Creating a Healthy Community, and Protecting Natural Resources With a goal to encourage more families and young people to connect with our local farms and the products they offer, as part of the "Eat 40% Local" campaign, the Food Action Team coordinated the 7th annual Local Eats Week, featuring local ingredients prepared by chefs at 13 restaurants, and prepared 1,000 recipe cards for distribution at the Farmers' Market and to 2,000 individuals weekly via social media The team also distributed the 7th edition of the Corvallis Garden Resource Guide to 500 current and prospective gardeners, coordinated three Edible Garden Tours, and led a local event on National Food Day that featured a community Apple Crunch and distribution of free Farmers' Market tokens to 100 children The Health and Human Services Action Team launched a Green Cleaning Campaign to encourage people to choose safe alternatives to hazardous household products, the promotion included a presentation by the Oregon Environmental Council, distribution of 200 green cleaning kits, and a survey of schools, day care centers, and other facilities to assess cleaning policies and practice The Water Action Team discovered, in collaboration with the OSU College of Engineering, that artificial turf on athletic fields drain toxic substances into local creeks, so the team consulted with the City of Corvallis about developing requirements for storm water treatment The team also initiated the first project to regenerate a lost creek (the headwaters of Dunaw Creek), collaborated with the Confederated Tribes of the Grand Ronde and the City of Corvallis to sponsor the Lamprey Creek Awakening Ceremony in honor of the naming of Lamprey Creek, and organized creek-side work parties and plantings to help protect the lamprey fish in the creek The Natural Areas Action Team coordinated the 7th annual Natural Areas Celebration Week with 23 events that engaged 650 citizens in appreciating local natural areas (Grants \$ 350) If this amount includes foreign grants, check here . . . ☐	30a	3,277

Strengthening Transportation Options, Promoting Economic Vitality, and Encouraging Waste Prevention In an effort to foster a culture of cycling and transit ridership, the Coalition's Transportation Action Team provided bike valet services for hundreds of attendees at Septembeerfest and the Fall Festival, using bike racks that were transported by bikes In addition, the team sponsored Pedalpalooza, a car free festival featuring people-powered transportation, held in conjunction with the 7th annual Car Free Day in Corvallis The team also sponsored the 2nd annual "Trip-by-Transit" that guided riders of the Linn-Benton Loop bus, to, from, and around Albany and included visits to a local restaurant, the Farmers' Market, and Talking Water Gardens water reclamation system The Economic Vitality Action Team partnered with Visit Corvallis to promote Travel Oregon's Bike Friendly Business Program to Corvallis businesses, and sponsored two Northwest Earth Institute discussion courses titled "Sustainability Works Rethinking Business as Usual " The team also co-sponsored the annual Buy Local First Day & Holiday Contest The Waste Prevention Action Team organized a campaign to expand the number of Recycling Block Captains, which resulted in a 50% increase, bringing the total to 90 captains who distributed waste prevention handouts on a quarterly basis to nearly 4,000 households The team also distributed 7,000 copies of the Corvallis-Area ReUse Directory and worked with OSU computer science students on developing an app of the directory for the Coalition website and smartphones (Grants \$ 250) If this amount includes foreign grants, check here . . . ☐		2,993
