Form 990-EZ, Part I, Line 10 - four undergraduate students from IDEa-funded institutions were supported to attend the NISBRE meeting.

These students were selected through a nomination process that involved principal investigators, teachers and mentors from eight different states in the IDEa program. Selection was based on academic performance and interest in pursuing a scientific career. A subcommittee of the NAIPI National Board, jointly with the NISBRE organizers, reviewed the applications and selected the four recipients.
