World Water Project is a team of social entrepreneurs who strive to deliver the world's best home water filter to those in the developing world. It is organized exclusively as a supporting organization for the benefit of, to perform the functions of, or to carry out the purposes of, the Knoxville Christian Community Foundation, a 501(c)(3) organization.

 World Water Project (d/b/a TivaWater) provides in-home biosand water filters to families in the developing world. In 2016, the organization shipped and distributed 2,160 filters to families in Guatemala and Uganda. World Water Project served and estimated 21,600 people between these two countries. Representatives from World Water Project spent an estimated 3 weeks making these distributions to communities. The primary short-term objective is to provide families with clean water. This service will impact individuals long-term by improving health, increasing income, fostering a better environment for education, and improving mental health.

4b (Code) (Expenses \$ 29,450 including grants of \$ 29,450) (Revenue \$)
 In 2016, World Water Project continued its support of a poultry farm school, Chicken City Farms, located near Kampala, Uganda, through financial support and mentoring. This working farm teaches necessary skills to the workers who will graduate and eventually run their own farms. The farm has a capacity of producing 4,000 broilers per week.

 World Water Project continues to support the FOCUS Child Project, a program that supports children from the Mulago-Kalerwe slum community in Kampala, Uganda. These children are supported financially through individual sponsorships so that they have the opportunity to attend school and also be provided with their basic needs. World Water Project provides financial support as well as links U.S. families to sponsor school-aged children.
