SECOND: The Articles of Incorporation of the Foundation are hereby amended by the following:

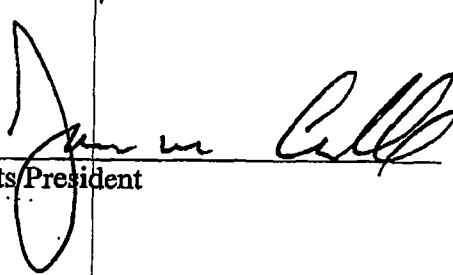

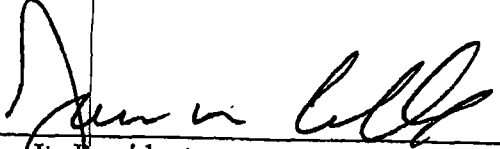
