In addition to the printed report, Explore Mars maintains the H2MR website that archives support materials used to produce the printed report. The site serves as a valuable resource for interested parties and members of the public. Each annual report is presented at the annual H2M Summit. Each year, the report is distributed to all members of Congress, industry leaders, space policy experts, NASA officials and members of the interested public. Explore Mars doesn't charge for the publication and a copy is available on the Explore Mars web site.
