Cambodia - This country is still recovering from a recent genocide, and struggles with poverty, trafficking, HIV, violence, and corruption that has left the majority of the populace in a disadvantageous position. To assist, GR initiated bi-monthly leadership classes for community leaders from provinces nationwide. In 2016, seventy-five leaders were trained in our facility and in the province of Takeo. Ongoing programs take place in the capital and provinces affecting over 3,000 people in the areas of food distribution, educational training, and feeding programs. The organization has also established educational sponsorships that provides monthly assistance to around 100 children in order for them to attend school. A dormitory for university students and music and worship programs have also been initiated for the youth.

Selah Safe Houses - Our first safe house for children that were enslaved for forced sex and labor began in the capital city of Phnom Penh in 2011. We care for a total of 14 children that are provided, protected and cared for in safe house in Cambodia. Five little girls are cared for in our Indonesian Selah home. There are 8 total members of staff that are on-site and work tirelessly to ensure the safety and growth of the children. These roles include one House Manager, Counselors, Social Worker, and Regional Manager.

Vietnam - The tragic Vietnam war and occupation of the South by the North, has led to oppression, corruption, poverty, and lack of advancement for the majority of the people. Global Renewal has helped establish leadership training programs in the cities of Ho Chi Minh and Hanoi. Here people from all over Vietnam come and receive education, life skills training and leadership skills, in order to be effective community leaders. The graduates of this program go back to their respective communities/villages and become agents of change. Global Renewal is also working to help eradicate illiteracy among both young and old in the tribal areas of the North. In 2016, Global Renewal educated 35 people.
