Our mission is to expand global access to low-cost clean water technologies and information about health and sanitation through knowledge-sharing, training, community-building, peacemaking, and sustainability. Through community training in the use and construction of BioSand filters - not only is sustainable clean water technology available but the local filter building teams form the basis of small micro businesses creating a sustainable source of the filters and clean water for the community.

Democratic Republic of the Congo: In 2016 and continuing through 2016 FFWF launched a campaign "We Stopped Cholera", designed to combat endemic Cholera in a number of orphanages and refugee communities in Goma DRC. Working with a FFWF affiliate in the Goma area (Dr Kambale Musubao and his nurse, wife) : FFWF was able to train local filter building teams, construct and install BioSand filters in 26 orphanages and another 150 filters in the nearby villages. The work targeted three main elements: 1) training displaced persons and other refugees in the construction, installation and use of BioSand filters. 2) hiring these local teams to build filters for orphanages, schools and communities with high HIV/AIDS rates, and 3) fostering the development of local self sufficient enterprises to continue the production of water filters locally, insuring expanding access to safe water. Schedule O includes a list of project funded in the DRC in 2016. Most projects developed under this program require filter recipients to either pay or contribute labor for the filters they receive. FFWF maintains a subsidized program for schools, clinics, orphanages and families struggling with HIV/AIDS. WE offer a "Card Fund program where stateside donors may purchase holiday/gift cards and those funds are used too subsidize the cost of the filters for these recipients.

Rwanda BioSand Filter Program - BioSandFilter construction and community based filter building team training (28+ filter teams trained). With with local FFWF affiliate and volunteer field coordinator Niyitigeka Patience and local community groups "Hand in Hand" and "God in Us Africa " to foster the distribution of BioSand filter technologies in rural Rwandan communities. Trained Teams have been able to build, sell and install filters locally, creating sustainable micro-businesses that can cost effectively and sustainably meet demand for clean water. Expenditure for this elect of Rwandan Project: \$46,686.00 Rainwater Catchment Training : FFWF initiated in late 2016 and (implemented in 2017) a 7 day training in the construction and installation of rainwater catchment cisterns. We worked with 5 newly formed construction teams and the FFWF volunteer field coordinators from East Africa to build rainwater catchment devices that could be used in conjunction with the FFWF biased filters. FFWF seed money was used host the training , But all subsequent rainwater catchment building will be handled locally by the construction teams and will be self sustaining. Expense for this element of the Rwanda work: \$21,370.00

Kenya Community BioSand filter training: BioSand filter construction, health and sanitation training, initial support of local filter build teams. Training on construction and installation of filters in schools, orphanages, along with the recruitment and training of new volunteers from local community and faith based organizations in Kenya to be able to continue the wrk and expand access to BioSand filters after the American volunteers leave Kenya. FFWF costs covered construction materials, reusable steel filter molds , workshop space, training aids, travel and logistical support for trainers.
