The mission of HKF is to bring reliable and sustainable healthcare to the people of Kajo Keji, South Sudan. This was accomplished by the continuing operation of a clinic there which is operated by local doctors and staff. The mission was also accomplished by a 26-person mission team (doctors, nurses, pharmacists) traveling to Kajo Keji in March 2016 to hold medical clinics in several villages, help improve the water conditions, and share Christ with those who came to the clinics.

Salaries of doctors and staff at the clinic in Kajo Keji, South Sudan. The Healing Kadi Foundation raises funds to cover the salaries and wages of the doctors, nurses, pharmacists, and other personnel who operate the clinic in South Sudan that opened in June 2013. Although there were few gifts designated for salaries of the clinic personnel, the general funds and other fund-raising events covered the cost. The clinic in South Sudan is responsible for all local and governmental taxes as well as the retirement amount.

4b (Code:) (Expenses \$ 69,129 including grants of \$) (Revenue \$ 66,775)
Mission trip to Kajo Keji, South Sudan. A medical/teaching team of 26 people traveled to South Sudan in March 2016 to provide medical care to more than 10,000 people who came to the clinics being held in different villages by the doctors and nurses who went. This was a pass through amount as each participant paid their own way, but it was channeled through HKF who made all the arrangements and paid all the expenses.

Medicine: Through several channels, medicine was purchased to take to South Sudan on the Mission Trip. Some money was given specifically for the purchase of the medicine.
