This goal has been largely met by funding the renovation and restoration of a long defunct and unused tennis camp in the center of Jeffersonville Village. As a result, the Cambridge Community Center had a soft opening in October 2016 and a grand opening in January 2017

Since opening the center has hosted many community events including the Cambridge Area Rotary Fun Run, the Cambridge Music Festival, Cambridge 4th of July events, the Cambridge Arts Council Festival of the Arts, the local Cambridge Rotary Ski Swap, and many other community events.

In addition to the community event schedule the field house schedules year round sports leagues, training times, and clinics for both youth and adults for futsal (indoor soccer), tennis, volleyball, paddleball, and lacrosse. Basketball hoops are the next project on the list.

The center also has opened a fully equipped fitness facility and offers fitness classes and training, yoga, dance, Zumba, and a host of other wellness related classes

The center serves all ages of the community. Hundreds of athletes participate in the sports leagues and clinics, the fitness center has over 200 memberships, and wellness classes are attracting wide variety of community members looking to improve their health and wellbeing.
