We establish safe houses to provide maximum safety for endangered children in an environment for healing within a licensed home setting, through crisis counseling, trauma therapy and education. We offer specialized care for victims of ritual, clergy, incest, mental, physical and sexual abuses, along with comfort and education for their families. We offer these services for free. We promote public awareness in training seminars and interviews locally in radio, tv, speaking engagements and fundraisers to listeners by educating on the escalating crimes of child abuse through child pornography, neglect and exploitation, causing human suffering within our communities and our nation. We strive to be a voice for abused children.

Our renovation of our first safehouse was completed for operation at its present size of 6+ beds as a foster home, as we move forward on an addition to double our capacity in beds so that we can acquire a new license as a child welfare agency. We are becoming a model for current and future efforts of providing safety, protection, trauma recovery, crisis counseling and healing to children and their families when possible. We look to establish more safe-houses in conjunction with other non-profits to provide maximum safety for endangered children in an environment for healing, through crisis counseling, trauma therapy and education. We offer specialized care for victims of ritual, clergy, incest, mental, physical and sexual abuses, along with comfort and education for their families. We do these services for free. We promote public awareness in the community on the escalating crimes of child abuse, pornography, neglect and exploitation, while training children and adults on Internet safety within online games, chat rooms and the varied uses of social media.

We promoted public awareness in educating the community on the escalating crimes of child abuse, pornography, neglect and exploitation, through training children and adults on Internet safety within online games, chat rooms and the varied uses of social media. We are currently working on 2 movies and public service videos for curriculum training in schools, churches and public outreaches for education of the public in the prevention and intervention of child abuse, trafficking and promotion of Internet and social media safety. We promoted awareness in training seminars and interviews locally in radio, tv, public speaking engagements and fundraisers to thousands. We promoted community outreaches locally to help 500 children in need adopted for Christmas.
