See Schedule O for Program Service Accomplishments Sustainable Fisheries Partnership Foundation (SFP) comprises approximately 70 staff and contractors working to engage and catalyze global seafood supply chains in rebuilding depleted fish stocks and reducing the environmental impacts of fishing and fish farming, with major projects in Asia, Europe, and North and South America SFP convenes, educates, and advises supply chain stakeholders including major retailers, restaurant chains, seafood brand owners, buyers, producers (fishers), NGOs, and fisheries management and scientific institutions to improve fisheries practices and policies Some of SFP's oldest partners include McDonald's, Walmart, and High Liner Foods In June 2016, SFP entered into partnership with Alcampo, Spain's second-largest hypermarket chain Three months later, US Foods, the second largest foodservice company in the US, also became an SFP partner A full list of SFP's partners can be found on our web site at www.sustainablefish.org A main component of SFP's strategy includes improving access to information used to guide responsible seafood sourcing SFP implements this strategy in a number of ways, including by catalyzing and advising Fishery Improvement Projects (FIPs) and Aquaculture Improvement Projects (AIPs) A FIP or AIP is a collaboration among relevant stakeholders to influence policies and management practices and improve the sustainability of fishing and fish farming operations Once established, a FIP functions as a continuous improvement vehicle that aligns the interests of the supply chain It sets and implements its own improvement objective (using public workplans and measurable milestones) and is designed to be led by industry and to outlive the initial involvement of NGOs such as SFP, functioning as long as necessary to achieve sustainability goals Worldwide, SFP is currently advising improvement in more than 90 FIPs and AIPs Several notable events regarding FIPs and AIPs occurred in 2016 In January, a new public report was published on a tilapia AIP that SFP has supported in Hainan, China This AIP led to the first industry-driven set of voluntary standards designed to ensure seafood farms are functioning in a sustainable manner In February, a Mexican shrimp FIP in the Gulf of California that SFP has advised earned certification from Fair Trade USA, based on improved working conditions there With SFP's guidance, Thai Union Group PLC also began work in June on a multi-species trawl FIP in Thailand's Andaman Sea In 2016, SFP also unveiled a new evaluation tool that gives FIPs a rating based on their progress The ratings include a "stage" level along with a letter grade system This helps pinpoint which FIPs need to improve and which are performing according to expectations SFP also organizes fish buyers into supply chain roundtables (SRs) that oversee the creation of FIPs and AIPs in their areas and monitor progress An SR is a forum for processors, importers, and others that buy directly from a specific seafood sector to work together in a pre-competitive environment to achieve improvements in fisheries or aquaculture Currently, SFP works with approximately 19 supply chain roundtables In 2016, SFP began emphasizing industry-driven efforts over SFP initiating FIPs, AIPs, and similar projects on its own Accordingly, SFP clarified its definition of an SR, and presented an informative document to partners SFP also plans and holds many SR meetings to coincide with the major annual seafood industry trade shows in Boston and Brussels This gives SR participants a chance to meet in person to discuss progress and related issues, plus it gives SFP the chance to be on hand face-to-face with the participants to answer questions, provide updated data connected to a particular project, and offer additional information Among the SR meetings held in Boston in 2016, for example, was a meeting to discuss the status of a Mexican grouper FIP The meeting was so effective that three companies - Quirch Foods, Chefs Trading, and Mexican seafood distributor Pescados y Mariscos del Caribe S A (PESMAR) - all decided to join the FIP as a direct result of the SR meeting in Boston SFP engages and educates the seafood supply chain by sponsoring annual Fisheries Forums in North America and Europe that provide opportunities for our partners and other stakeholders to meet, learn, share information and lessons learned, and decide strategies for achieving sustainable fisheries The forums are specifically scheduled to prepare our partners for the annual seafood expos in Boston and Brussels, where they make many of their purchasing decisions In February 2016, SFP held its Americas forum in Miami More than 120 people attended the forum, including representatives from SFP partner companies High Liner Foods, Wegmans, Nestle Purina Pet Food, and Fortune Fish and Gourmet Presenters and panelists discussed various issues pertaining to sustainability, including traceability, aquaculture, and the value of FIPs in sustainable seafood In April 2016, more than 80 delegates representing 90 percent of our European partners attended the European forum in Dublin They discussed the use of SRs, issues relating to transparency, and the upcoming landing obligations under the revised EU Common Fisheries Policy Another important information tool SFP uses to inform improvement in fisheries is its FishSource program-an online information resource that records the status of fish stocks and fisheries SFP created FishSource (www.fishsource.com) so that fisheries experts around the world can share their public scientific and technical information and provide major seafood buyers with up-to-date, impartial, actionable information on the status of fisheries and the improvements that are needed to become sustainable Currently, FishSource provides public information on 1,068 stocks or salmon regions (with another 60 under development) and 3,009 fisheries (with another 113 under development) In 2016, developers at SFP announced a new version of FishSource, which includes a improved user-friendly interface and an upgrade to the underlying database, which enables, among other things, more flexibility and compatibility with other systems such as RAM Legacy and Monterey Bay Aquarium's Seafood Watch The new version also incorporates SFP's Human Rights Abuse Risk indicators
