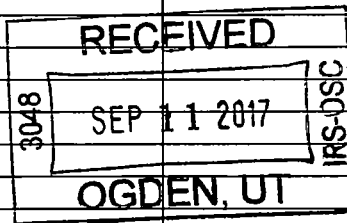

UPON OCCASION, THE ORGANIZATION HAS FUNDED TRANSPORTATION EXPENSES OF THOSE MOTHERS THAT ULTIMATELY FIND JOBS. THE CHARITY HAS PAID FOR TRAVEL EXPENSES OF FAMILIES THAT DECIDED TO RELOCATE FROM GEORGIA TO OTHER STATES WHERE THERE ARE BETTER FACILITIES. VOLUNTEERS TEACH ENGLISH TO MOTHERS AND OLDER CHILDREN ON A WEEKLY BASIS AND TUTOR SCHOOL CHILDREN. HOLIDAY GIFTS HAVE BEEN PROVIDED FOR RELIGIOUS HOLIDAYS SUCH AS CHRISTMAS AND EID.
