Raise both awareness and funds for Sarcoma Research - The Paula Takacs Foundation For Sarcoma Research, A 501(c)(3) entity, was formed to raise awareness as well as funds for Sarcoma Research. Because Sarcomas only represent 1% of adult and 15% of childhood cancers, they lack the government funding that other cancers often receive. To further complicate the situation, there are 50 different types of sarcomas, all of which respond differently to treatment. Given those statistics and factor in the resistance that many of these Sarcoma types have to traditional cancer treatments, there is a need for private funding.
